

COUNTY COMMISSIONER MINUTES

DECEMBER 15, 2009

LARAMIE, WYOMING

1. **Roll call.**

The Regular Meeting was called to order at 9:30 a.m. by Chairman Sullivan. Roll call showed Sullivan, Chesnut and Gabriel all present.

**Public Hearing.**

**Consideration of Amendments to the Albany County Platting and Subdivision Resolution**

Doug Bryant, Planning Director withheld comment until the regular meeting.

2. **Public Comment.**

Bern Hinckley, inquired if there has been any dialogue with the City about the aquifer protection that is associated with the proposed Specific Purpose Tax and applauded the commissioners for wanting to open up that dialogue.

Doug Bryant, Planning Director spoke about wanting specific guidance from the Commissioners and how to move forward with the City on this matter.

Chairman Sullivan said that the dialogue needs to be opened specifically about aquifer protection and the airport.

Commissioner Gabriel, Jim Schermetzler, Deputy County and Prosecuting Attorney and Doug Bryant, County Planner were asked to meet with the City officials to begin the dialogue on the above two issues.

Sheela Schermetzler, Grants Manager mentioned that the Grant Agreement for action Item number 7 needs to be changed from \$2,995.27 to \$2,396.22.

5. Consideration of amendments to the Albany County Platting and Subdivision Resolution.

Doug Bryant, Planning Director spoke about the amendments to Subdivision regulations - the family exemption and unmanned communication facilities. These two amendments would bring the County provisions into line with state statutes. The Amendment to Chapter 1, Section 3(A)(1)(c) would state that a grantor's parcel of land must be titled in the grantor's name for a period of not less than five years prior to a transfer using the family exemption. Further, parcels created under this paragraph shall be titled in the name of the immediate family member for whom the division is made for a period of not less than one year unless such parcels are subject to involuntary transfer including, but not limited to, foreclosure, death, judicial sale, condemnation, or bankruptcy.

The unmanned communication facilities would be a new Section in Chapter 1, Section 3(A)(II) and would state that a division of land creating a parcel of five acres or less for the purpose of establishing unmanned communication facilities, compressor stations, metering stations, fiber optic booster stations or similar unmanned facilities.

MOTION by Gabriel, seconded by Chesnut to APPROVE the above listed amendments to the Albany County Platting and Subdivision Resolution.

6. Discuss County Annex parking and snow removal.

Doug Bryant, Planning Director spoke about the snow removal issue at the County Annex building. Doug inquired whether to contract someone to do the job or have Building Superintendent Garland Woods come and do it as needed. Chairman Sullivan asked about purchasing a snow blower. Doug Bryant will look into how much it would cost to contract someone to do the job and the cost of a snow blower and will report back to the Board.


