

**RESOLUTION NO. 2017-16**

**RESOLUTION APPOINTING MEMBERS TO THE ALBANY COUNTY COMMUNITY MENTAL HEALTH BOARD**

**WHEREAS**, on June 6, 2017, the Board of County Commissioners for Albany County (County) approved Resolution No. 2017-10 creating the Albany County Community Mental Health Board.

**WHEREAS**, pursuant to Resolution No. 2017-10, the County Commissioners were to appoint the following community partners to the Albany County Community Mental Health Board: 1. One (1) member from the Albany County & Prosecuting Attorney's Office; 2. One (1) member from Ivinson Memorial Hospital; 3. One (1) member from the Albany County Department of Family Services; 4. One (1) member from the Albany County Chapter of the National Alliance on Mental Illness (NAMI); 5. One (1) member from the Laramie Police Department; 6. One (1) member from Albany County Peak Wellness Center; 7. One (1) member from the defense bar representing the mentally ill in Title 25 proceedings; 8. One (1) member from the University of Wyoming Psychology Clinic; 9. One (1) member from of the Albany County Sheriff's Department.

**WHEREAS**, the first appointed members to the Albany County Community Mental Health Board shall serve staggered terms of one-third (1/3) for two years; one-third (1/3) for three (3) years and one-third (1/3) for four (4) years.

**NOW, THEREFORE, THE BOARD OF THE COUNTY OF ALBANY, WYOMING RESOLVES:**

**Section 1.** That, the following individuals are hereby appointed to the Albany County Community Mental Health Board for the following terms:

1. Peggy A. Trent, Albany County & Prosecuting Attorney's Office for two (2) years;
2. Linda Devine, defense bar representing the mentally ill in Title 25 proceedings for two (2) years;
3. Sheriff Dave O'Malley, Albany County Sheriff's Office for two (2) years.
4. Deb Hinkle, Albany County Chapter National Alliance on Mental Illness (NAMI) for three (3) years;
5. Jana Saltenberger, Albany County Peak Wellness Center for three (3) years;
6. Carolyn Pepper, Ph.D, University of Wyoming Psychology for three (3) years;

7. Kenneth Barrick, M.D., Ivinson Memorial Hospital for four (4) years;
8. Ty Peterson, Director of the Albany County Department of Family Services for four (4) years; and
9. Chief Dale Stalder, Laramie Police Department for four (4) years.


