

PLEDGE OF ALLEGIANCE

SPECIAL MEETING: 10:00 a.m.

1. **Roll Call.**
The April 11, 2018 Special Meeting was called to order at 10:10 a.m. by Chairman Chesnut. Commissioners Richardson and Jones present.

2. **Comments from the public.**
Jody Kalinay, resident of the proposed district informed the Board that she understood the action taken by the Board of County Commissioners at their April 3rd meeting was approval of the Pope Springs Community Special Road Improvement District excluding her property and understands now that it is being brought back today to be modified to include her property. She still feels that she will not benefit from the district as she do not use Pope Springs Road to access her property and has no legal access on that road.

Chris Cleven, Chief Petitioner informed the Board that he was shocked last week when the Petition was approved with the exclusion of the Kalinay property. He feels that they will benefit from the District and that their property should be included.

Peggy Trent, County and Prosecuting Attorney informed the Board that at the last meeting, she reiterated to the Board that what she indicated was to exclude the road and not the whole property. By statute, the Petitioner for the Road district should not include roads but only boundaries of the proposed district. In the petition they are proposing to fix private roads and they are not legally allowed to do so with public funds. Therefore, in the Findings all private roads will be excluded from improvement unless public access is granted by the landowner. Going forward we will have instructions for all Petitioners that want to form a road district. Everyone will have the same information and hopefully this will not happen again.

3. **Disclosures.** Commissioner Jones recused herself from item number 5, the Order for Pope Springs Community Special Road Improvement District that was approved at the April 3, 2018 County Commissioners Meeting.

Roll call showed Richardson and Chesnut. Aye. MOTION CARRIED. Jones recused.


6. ADJOURN.
