

Resolution 2019-024

RESOLUTION TEMPORARILY APPOINTING THE CLERK OF THE DISTRICT COURT FOR ALBANY COUNTY, WYOMING UNTIL A SUCCESSOR IS ELECTED AT THE NEXT GENERAL ELECTION AND TAKES OFFICE.

WHEREAS, on June 9, 2019, the Honorable Janice Sexton, Clerk of the District Court for Albany County, Wyoming submitted a letter to the Board of Commissioners for Albany County, Wyoming (Board) resigning her elective office effective July 31, 2019.

WHEREAS, on July 2, 2019, the Board declared a vacancy in the elective office of the Clerk of the District Court for Albany County, Wyoming pursuant to Wyo. Stat. § 22-18-101 (a)(ii) and Wyo. Stat. § 5-3-203.

WHEREAS, pursuant to Wyo. Stat. § 22-18-111, the Board on July 8, 2019 notified in writing the chairman of the Albany County Central Committee of the Republican Party which is the political party that Honorable Janice Sexton represented at the time of her election as the Clerk of the District Court for Albany County, Wyoming as to the vacancy of the elective office of the Clerk of the District Court for Albany County, Wyoming.

WHEREAS, the Chairman of the Albany County Central Committee of the Republican Party convened a special meeting of the Republican Central Committee on July 17, 2019, which is within fifteen (15) days after receiving notice from the Board of the vacancy of the elective office of the Clerk of the District Court for Albany County, Wyoming.

WHEREAS, on July 22, 2019, the Central Committee of the Republican Party for Albany County, Wyoming met, selected and transmitted to the Board three (3) persons qualified to hold the elective office of the Clerk of the District Court for Albany County, Wyoming.

WHEREAS, on July 25, 2019, within five (5) days of receiving the three (3) names from the Central Committee of the Republican Party for Albany County, Wyoming, the Board in a Special Meeting, which was duly noticed and published, held interviews of the three (3) persons qualified to hold the elective office to consider the temporary appointment of one (1) person of the three (3) to fill the vacancy of the elective office of the Clerk of the District Court for Albany County, Wyoming.

NOW THEREFORE THE BOARD OF COUNTY COMMISSIONERS OF ALBANY COUNTY, WYOMING, RESOLVE:

Section 1. That the foregoing recitals are incorporated in and made a part of this resolution by this reference.

Section 2. That Stacy Lam is hereby temporarily appointed to fill the vacancy of the elective office of Clerk of the District Court for Albany County, Wyoming as a temporary successor until a successor for the remainder of the unexpired term is elected at the next general election which is to be held on November 3, 2020 and takes office on the first Monday of the following January which is January 4, 2021.

Section 3. That Stacy Lam represents the Republican Party when appointed as the temporary successor to fill the vacancy of the elective office of the Clerk of the District Court for Albany County, Wyoming and is qualified to hold the elective office.


Section 4. That the Board requests the Clerk for Albany County, Wyoming to issue pursuant to Wyo. Stat. § 22-18-112, a Certificate of Appointment to Stacy Lam to fill the vacancy of the elective office of the Clerk of the District Court for Albany County, Wyoming.
