Re: Major Street Plan Update

Background:

The Urban Systems Advisory Committee (USAC) recently reviewed the Major Street Plan (MSP) and the Urban Systems Project Priority List. USAC approved amendments to the MSP map and approved the 2023 Urban Systems Priority Lists.

1. The 2023 Urban System Project Priority List as approved by USAC:

2023 Urban System Project Priority List			
Priority	Description	Approximate Length (miles)	Required Urban Systems Funds (Estimated)
1	Corthell Road from Whitman Street to future Bill Nye, and Bill Nye from the extension of Corthell Road to the extension of Boulder Drive; Bill Nye from Corthell Road to 15th Street	0.85	4,200,000 (2016 dollars)
2	Bluebird Lane, between Vista Drive and Grand Avenue	0.37	2,500,000 (2020 dollars, County Estimate)
3	30th Street, south to where it intersects with Bill Nye	0.84	5,600,000 (2016 dollars)
4	Pierce Street, Snowy Range Road north to Madison Street	0.59	?

2. Amendments to the MSP:

- Removed those streets mapped from the intersection of 45th Street and Crow Drive to the east end of Willett Drive and the north end of Boulder Drive.

- Extended Inca Drive to the most northerly proposed collector as shown on the Major Street Plan map.

Recommendation: Approve the 2023 Urban System Project Priority List and amendments to the Major Street Plan.

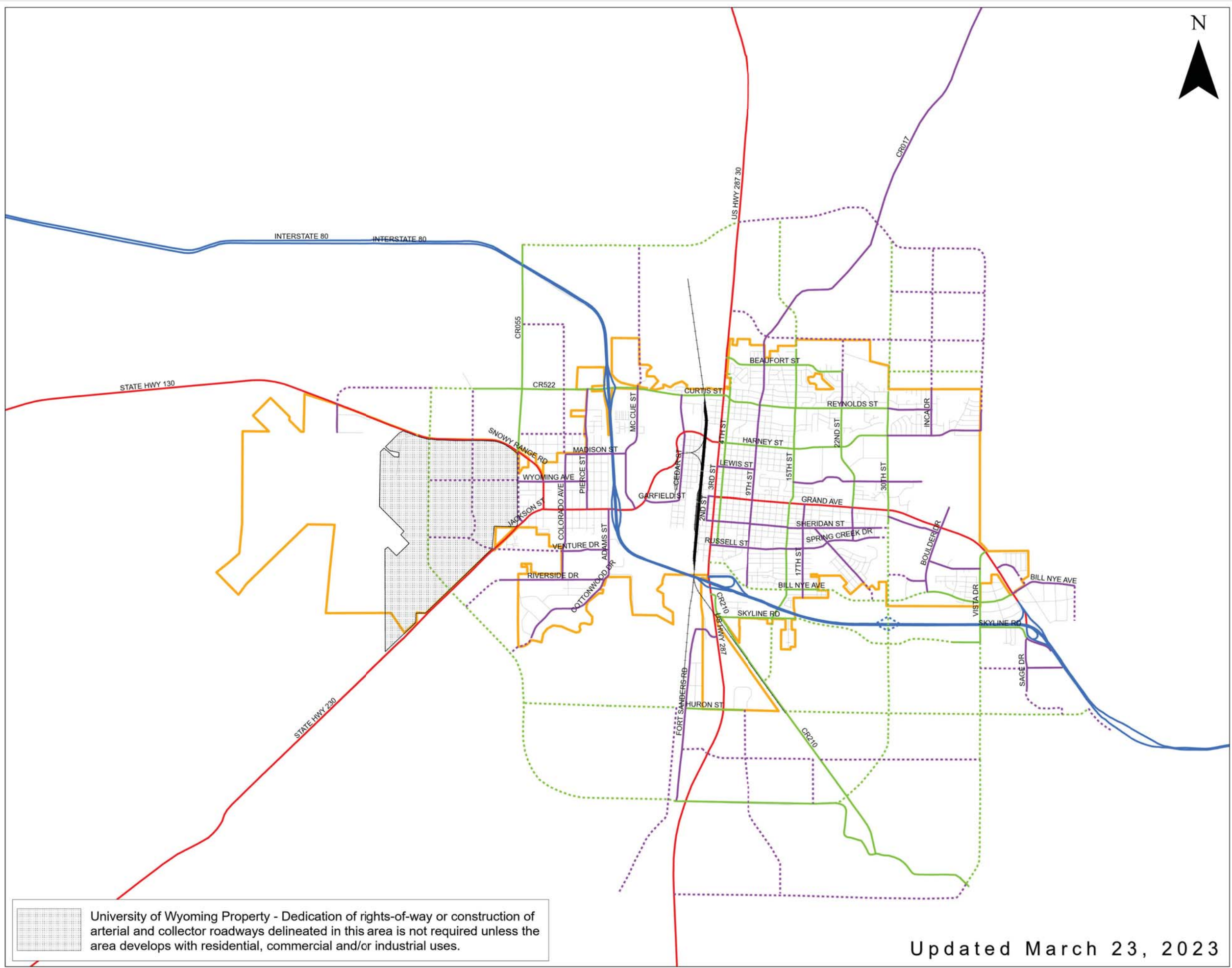
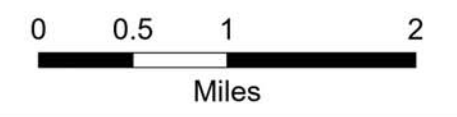


Major Street Plan
